TOURNAMENT NOTES

- 1. The official tournament schedule is the bracket board posted at the tournament headquarters. Check in continually for changes. It is your responsibility to keep abreast of all changes affecting your team's play. It is the team's 100% responsibility to be in the right place at the right time.
- Tie breaking procedures will be posted at the tournament site. If you have questions after reading the procedures, please ask the MSF manager for an explanation. <u>DO NOT WAIT UNTIL THE LAST MINUTE TO RESOLVE YOUR QUESTIONS!</u>
- 3. Should a forfeit occur within pool play at any time, all previous results of the forfeiting team shall be canceled. However, the forfeiting team may play the remainder of the schedule as an exhibition, provided their opponent agrees to play. Exhibition game scores will not be included when tallying the tiebreaker seeding/statistics. Forfeiting teams cannot advance to bracket play. Teams affected by a forfeit should report to the tournament manager immediately for further instructions.
- 4. In a three team pool where a "no-show" occurs, the two remaining teams shall play each other twice, unless the time schedule does not allow it. Tie breaking procedures will then determine the seeding in the championship bracket.
- 5. All pool play results count, unless there is a forfeit, in which case all results of the forfeiting team are canceled.
- 6. The top two teams in each pool advance to the Div AA State Championship Bracket with pool third place teams advancing to the Div A State Championship Bracket. Pool fourth place does not advance.




